Sources of family law. In Canada, family law is primarily statute-based. PROPERTY RIGHTS AND THE CONSTITUTION. INTRODUCTION. As part of the constitutional package announced in September 1991, the federal government proposed that the Canadian Charter of Rights and Freedoms be amended to guarantee property rights. This paper provides background information as to why these rights were not earlier included in the Charter.
